## Session Ends; Budget on Gov. Crist's Desk

The 2010 Legislative Session ended Friday, April 29th with the passage of a \$70.4 billion budget. The budget is now on the Governor's desk. Governor Crist is expected to sign this year's budget into law by Memorial Day weekend.

Looming large were two very different plans by the House and Senate to reform Medicaid, which currently represents one fourth of the state budget. However, SB 8 passed, empowering the Chief Financial Officer to investigate Medicaid fraud. For the first time, 27,000 high-level state employees and lawmakers must pay a portion of their health insurance premiums. Pay cuts for state workers and potential layoffs came off the table, as did efforts to push education reform. DMS will not be dismantled, but will now report to the Governor and the Cabinet. DOH will see some reorganization. OPPAGA will see a big cut in funding this year, which will most likely limit the number of reports released.

To fill the \$3 billion budget hole, the Legislature pumped in \$2.6 billion in remaining stimulus dollars, \$433 million from the Seminole gambling compact, \$507 million from various trust funds, and \$270 million from an anticipated FMAP dollars. For reserves, legislators put away \$1.4 billion, hoping that another \$730 million of FMAP will come down from Congress.

Both the House and Senate agreed to stash away \$1.8 billion in reserves with the possibility that another \$600 million could be added to that if Congress approves enhanced FMAP Medicaid dollars for states.

Although we are waiting for Governor Crist to sign the budget, DJJ's budget for 2010-11 will be reduced by \$14,870,449 or 2.4% from 2009-10.

### Next Year May Be Worse

State economists are predicting a \$6 billion budget shortfall next year which is double the deficit this year.

Amy Baker, with the Legislature's Office of Economic and Demographic Research says, "Next year, the budget is going to

### Recently Released Reports

#### **OPPAGA: Redirection Saves \$51.2 Million over the Last Five Years**

OPPAGA's newest report on the Redirection Program states that it has achieved \$51.2 million in cost savings since its inception five years ago. The report states that youth who successfully completed the program were significantly less likely to be subsequently arrested for a felony or violent felony, adjudicated or convicted for a felony, or sentenced to prison after treatment than similar youth who successfully completed residential commitment programs.

This year's report included analysis that considered risk assessment data based on the Positive Achievement Change Tool (PACT). Additionally, OPPAGA made some new recommendations in the 2010 update. They include expanding services to serve gang involved youth and some juvenile sex offenders. Also noted, Redirection continues to significantly reduce recidivism, but the effects are not as strong as found in previous studies.

#### **Center for Juvenile Justice Reform**

Georgetown University's Center for Juvenile Justice Reform has released a report titled, *Addressing the Unmet Educational Needs of Children and Youth in the Juvenile Justice and Child Welfare Systems*. In this report, Dr. Peter Leone from the University of Maryland, and Dr. Lois Weinberg from California State University, Los Angeles, offer six principles to address the educational needs of "crossover youth," as well as policy and practice steps to improve their outcome.

be much tougher, and not because the economy isn't growing and showing good signs of life. But when that stimulus goes away, how do you replace it?" Other concerns include Florida's current unemployment rate, which continues to rise, and how lawmakers will be able to pay back the trust funds which they have raided for the last two sessions.

During the last two sessions, the Legislature debated the value of closing loopholes in tax exemptions, taxing purchases on the internet, and other ideas to generate more revenue for the state. Despite these discussions, very little tax reform has taken place. Discussions this year, as an election year, did not advance further than the year before.

However, with upcoming budget deficits like we have never seen, no remaining stimulus dollars and now no potential revenue from oil leases in the Gulf, next year will likely become the year where legislators will be forced to look at real solutions no matter how painful the discussion will be.

#### **U.S. House Signals Readiness to Reauthorize the JJDP**

The U.S. House of Representatives appears ready to introduce legislation that would strengthen and better fund the Juvenile Justice and Delinquency Prevention Act (JJDP). A hearing on the reauthorization was held on April 21, 2010, at 10:00 a.m., before the full House Education & Labor Committee. The JJDP expired in 2007 and is two years overdue for reauthorization.

The U.S. Department of Justice recently released a position letter voicing strong support for the reauthorization.

The Juvenile Justice and Delinquency Prevention Act is the federal legislation affecting youth in juvenile justice systems across the country. It is the legislation that sets the standards for state and local juvenile justice systems, and provides direct funding for states, research, training and technical assistance, and evaluation.

### Nominations Sought For Two Open FJJA Executive Committee Positions

The FJJA nominating Committee, chaired by Past President Jim Hill, has developed a slate of nominees for vacant positions coming available on July 1. *However, the floor will be open for nominations during the Retreat.* The election will be held on June 16, 2010 at the FJJA annual retreat.

Available are Board Secretary and one At-Large position, both serving on the Executive Committee. Those not attending the retreat may vote via e-mail, telephone or proxy according to the FJJA By-Laws. There is one vote per Agency Membership. Associate Agency Members and Ex Officio Members do not have voting privileges.

Those elected will serve for a period of two (2) years. Ballots and voting instructions will be emailed to members, along with Retreat Board packets, in the next two weeks.

### DJJ Announces Changes To Dozier

DJJ announced this month changes relating to the Dozier School for Boys. Assistant Secretary Darryl Olson recently announced a plan that will reduce the school's budget by \$2.5 million annually. Changes also include shedding the Dozier name, which has been a source of controversy for years and especially since a group of men came forward with stories of abuse.

The facility will be called the North Florida Youth Development Center and will include merging the adjacent Jackson Juvenile Offender Correction Center. The capacity of the school will be reduced to 151 beds from 199. Sixty-four staff positions will be eliminated, of which only 27 were currently filled.

The facility will also now serve developmentally disabled males who need behavioral treatment. This year, the Legislature introduced proviso language that will ensure oversight by community leaders to help monitor progress and address concerns of the legislature, advocacy groups and the media.



## **Home Builders Institute Earth Day Activities Make An Impact Around the State**

### **Okeechobee Youth Development Center**

For Earth Day, a conservationist visited Okeechobee Youth Development Center to talk to the HBI students. HBI students worked in groups with other OYDC students talking about conservation issues.

### **Orlando**

On April 24, HBI students in partnership with the Coalition for the Homeless, Orange County Public Schools and community volunteers gathered to assemble Inter Shelter Domes at Lake Eola Park in downtown Orlando. Envirodomes are used as quarantine shelters, emergency relief situations and long term housing in place of temporary tents and wooden structures that do not provide safety or reliable in extreme conditions. The completed dome was shipped to Haiti to help a family in need.

### **Okeechobee Girls Academy**

The students at Okeechobee Girls Academy built planters behind the HBI building to use for planting fruit trees and vegetables. This will teach the students the importance of growing and caring for plants. Under the guidance of the instructor, the students also built screen doors on hinges to keep pest from eating the plants. In addition, youth volunteered at a local church landscaping, cleaning, and painting.

### **Red Road Academy**

Red Road Academy students got their staff involved by asking them to sign an Earth Day Pledge, encouraging them to turn conserve water and electricity. Students cut leaves from green construction paper and had the staff write their pledges on the leaves. Afterwards the leaves were placed on a tree poster. In addition, youth volunteered at a local church landscaping, cleaning, and painting.

### **Avon Park Youth Academy**

On April 23, 2010, the first day of Global Youth Services Day, seven students and two landscape instructors in Avon Park Youth Academy participated in an on-going program at Hammond State Park to help eradicate exotic and invasive plants in the campground area. The park has numerous exotic and invasive plants that have no known pests or diseases that will hinder their growth and are slowly choking out native vegetation. Students removed several truckloads of plants, which has also helped to improve the function and appearance of the campground area. In return, Park Service Ranger Travis Martin gave a presentation to the students on native Florida plant species and the concern of evasive plants in Florida.

### **Dozier School for Boys**

For Global Earth Day youth at Dozier School for Boys planted Japanese Maple trees along the entrance of the Dozier facility in an effort to add color and shade. The Japanese Maple tree is fast growing and leaves change from green to red. In addition, the students entered the tree planting awareness poster competition. Students built 10 bird feeders that were donated to 2 convalescent centers and a rehabilitation center in Jackson County and 48 birdhouses for a facility in Dothan, Alabama. They also built and donated a picnic table to the New Beginnings Worship Center's youth group in Grand Ridge, FL.

### **Bristol Youth Academy**

At Bristol Youth Academy, gardening, part of the facility maintenance program, is taught to 40 youth per year. As part of Earth Day, these students developed a vegetable garden and recently refurbished the flower beds in front of the facility by cleaning out the old beds and prepared the soil for marigolds, begonias, yellow squash, cucumbers and watermelons.
