## FJJA Develops 2011-2012 Legislative Agenda at Retreat

Since legislative session will start two months early next year, FJJA members finalized and approved the 2011- 2012 Legislative Agenda at the annual retreat.

In the August newsletter we will be updating members on our legislative timeline, local events and other activities that will take place during the summer and fall.

## NCCD Conducts Listening Session at the FJJA Annual Retreat

Lawanda Ravoira, director of the NCCD Center for Girls and Young Women recently held a listening session at the FJJA Annual retreat. The goals of the listening session were to capture the experiences, suggestions and concerns identified by service providers and stakeholders about girls involved with the juvenile justice system.

NCCD hopes this OJJDP funded project will inform improvements to the standards of care for all girls programming by better identifying the resource and information needs of girls.

Information learned from the session will be merged with input from around the country and presented at the OJJDP national conference being held in Washington D.C. in October 2011. FJJA will provide members with the presentation by NCCD later this year.

## FJJA 2011-2012 Legislative Agenda

### No Cuts to Juvenile Justice

*Maintaining funding will:*

- Reduce crime, victimization and other related costs;
- Reduce the flow of youth into adult corrections and need for future prison construction.

### Increase Investment in Community Based Services

*Increase funding for:*

- Prevention, early intervention and diversion programs;
- Community based residential services;
- Transition, reentry and aftercare services;
- Education, vocational training and job placement.

### Investing in Florida’s Juvenile Justice System Ensures Public Safety

*Key Points:*

- Last year, DJJ received the largest funding cut in public safety.
- Very few resources have been earmarked for reinvestment into community based services.
- Of the \$77 million cut, only \$5 million will be reinvested.

### After 36 Years, Outward Bound Shuts Down The STEP Program

The Short-Term Expedition Program (STEP) was closed last month as a result of policy changes within the Department of Juvenile Justice as they work to serve more misdemeanor youth in their home communities.

The Yulee Outward Bound program, which operated for 36 years in Florida, had served teens throughout the state, and was the only such program in Florida for teen delinquents.

The program was geared to male and female teens from 14 to 18 who had been arrested for minor misdemeanors up to first-degree felonies - crimes such as shoplifting and petty theft.

Youth who were sentenced to the program were chosen on a case-by-case basis, excluding a history of violence with a weapon. The program graduated over 9,000 participants. The program had

great partnerships with the community through its community-service work. Youth in the program volunteered in the local community, doing trail maintenance at Fort Clinch State Park, working with animals at White Oak Plantation and serving meals at the Clara White Mission in Jacksonville, as well as local nursing homes.

Jon Howard, Director of At-Risk Programs for Outward Bound said, "There are lots of former alumni who say the course changed their life."

There are two remaining Outward Bound programs in Florida, one in Brevard County that serves non-delinquent teens struggling with home and school environments, and a program in Monroe County that is an alternative school that serves students in grades 7-12.

### DJJ Partners with Georgetown University in Effort to Improve Juvenile Justice

The Florida Department of Juvenile Justice has been selected to participate in a national initiative to improve its juvenile justice system by translating "what works" into everyday practice and policy. The Juvenile Justice System Improvement Project (JJSIP), administered by Georgetown University's Center for Juvenile Justice Reform, will provide a framework for implementing best practices throughout the entire juvenile justice system. Pinellas County has been selected as the demonstration site for the project.

"We are deeply grateful for this opportunity to improve outcomes for youth in our care and are honored that Georgetown recognized Florida's suitability for this project," said Secretary Wansley Walters. "Historically, juvenile justice programs have been evaluated with respect to recidivism rates. After this project is complete, we will have a better understanding of why some programs have better outcomes than others. This will ensure continuous quality improvement of services for all our youth."

The project will produce an evaluation tool to identify any shortcomings in juvenile programs or services, evaluate how closely those programs or services align with the most prominent research in the field to help identify concrete recommendations for improvement. The Georgetown team will work with prominent criminologists to provide technical assistance to the state throughout the 18-month

project period beginning later this summer. The team will evaluate DJJ's services to ensure an adequate range of graduated sanctions with interventions designed to reduce the risk of committing future offenses. At the end of the process, Florida will have implemented the JJSIP fully in Pinellas and work to implement it statewide.

### Secretary Walters Rounds Out the DJJ Executive Leadership Team

Secretary Walters has announced new additions to her leadership team, including naming Michael McCaffrey, former director of Staff Development and Training, as the new assistant secretary of Probation and Community Intervention. Wanda W. Finnie has been named as assistant secretary of Prevention and Victim Services. New to the department, Wanda served as a prosecutor and public defender in Pennsylvania and New Jersey before moving to South Florida, where she worked at the Miami-Dade County Juvenile Services Department as Special Projects Administrator. Last month, Robert Woody was named as the new Deputy Secretary of the department.

According to report Since FY 2002, federal investments in programs that prevent and reduce delinquency have decreased by 50%. Over that same period, federal spending on policing, prosecution and incarceration has increased by more than 60%. **U.S. DEPARTMENT OF JUSTICE:** *Highlights of the 2009 National Youth Gang Survey*

This fact sheet presents findings from the National Gang Center's 2009 National Youth Gang Survey, which collects data from a large, representative sample of local law enforcement agencies to monitor the size and scope of the national gang problem. The prevalence rate of gang activity increased slightly from 32.4% in 2008 34.5% in 2009. Over the entire survey period, three trends are apparent in the prevalence rate of gang activity: a sharp decline throughout the late 1990s, a sudden upturn beginning in 2001 and continuing until 2005, and a relative leveling off thereafter. Larger cities exhibited a large and stable prevalence rate of gang activity from 2005 to 2009, while the less populated areas reported a smaller rate with a more fluctuating pattern. ### The Girls Haven't Gone Bad, Mr. Epps: They Just Need Help

As the Director of the Center for Girls and Young Women, I am deeply disturbed by recent remarks of Charles T. Epps, Superintendent of the Jersey City Schools. On April 13th, Epps announced to a group of interdenominational pastors that the girls of Jersey City are responsible for the community's problems. "Our worst enemy is the young ladies," he said. "The young girls are bad. I don't know what they're drinking today, but they're bad." Just as disturbing, it seems that no one in his audience spoke up to disagree.

How can we empower our girls to succeed when public leaders place the blame for societal problems squarely on their young shoulders? Rather than assigning blame, Epps should be addressing the challenges and traumas that can cause young women to begin a pattern of difficult and even dangerous behavior.

Young women are the fastest growing segment of the juvenile justice population, and their juvenile justice involvement is a result

of circumstances distinctly different from those of males. Research demonstrates that up to 92 percent of the girls in the juvenile justice system are victims of physical or sexual abuse. Yet policies and procedures focus overwhelmingly on punishment; often further traumatizing girls who have been pushed into the system by victimization. As a community leader, Epps should understand that many troubled girls suffer in a system that lacks the knowledge and resources necessary to serve their needs.

NCCD's Center for Girls and Young Women is working to reform social and juvenile justice systems that have failed to meet the specific needs of girls and young women. The Center is listening to girls across the country, identifying their real concerns, and working with juvenile justice practitioners to find ways to address their needs. As we do so, we need public leaders to help us change a system that is failing young women who deserve treatment and support – not vilification and blame. The time has come for our leaders to take responsibility for protecting young girls and providing them with the tools they need to succeed.

Instead of tearing them down further, Superintendent Epps – and all of us – should support our girls and help them to thrive.
