Featured Speakers

Jaiya John, Ph.D. — Nationally recognized inspirational speaker; poet; author; youth mentor and advocate. Dr. John, of African American and Blackfeet and Cherokee descent, grew up immersed in New Mexico's American Indian and Latino cultures has a deep appreciation for the spiritual and communal passions that spring from these worlds. This spirit he ingrains in his messages about our social world. He also speaks with the voice of a person who grew up in the foster care system.

Shay Bilchik, J.D. — Founder and Director of the Center for Juvenile Justice Reform at Georgetown University's Public Policy Institute. The Center's work aims to focus the nation's leaders, across systems of care and levels of government, on the key components of a strong juvenile justice reform agenda. A particular focus of the Center's work is on youth known to both the child welfare and juvenile justice systems, also known as "crossover youth."

Wansley Walters — Secretary, Florida Department of Juvenile Justice. Secretary Walters earned national recognition for her work in Miami-Dade County. Working with law enforcement and social service agencies, and through the use of civil citation, to nonviolent first-time juvenile offenders were diverted, saving taxpayers millions of dollars. From 1998 to 2008, arrests fell by 46 percent, with re-arrests by 80 percent.

Girl Differences: Honoring Each Girl and Young Woman's Lived Experiences

On April 25, 2012, The National Girl's Institute (NGI), a partnership between NCCD's Center for Girls and Young Women and OJJDP, will facilitate a one-day intensive Post Conference at the 2012 Adolescent Conference. The Post Conference Training Event, entitled *Within Girl Differences: Honoring Each Girl and Young Woman's Lived Experiences* will include workshops that highlight the within girl differences of young *women* of color; the needs of girls with lived experiences of trauma and loss; and effectively providing interventions for meeting the needs lesbian, bisexual, questioning and transgendered youth. Additionally, a workshop that focuses on Staff Matters® will be presented that provides strategies for finding personal and professional balance as caregivers to girls and young women.

VALUING DIFFERENCES: Creating Culturally Competent Programs and Services

Girl-services organization(s) must commit to promoting the development of a healthy-cultural identity for the young women they serve. Providing effective services is impossible without the knowledge, understanding and respect of the culture and background of girls and their families/caregivers. It is no exaggeration to say that a culturally competent provider can mean the difference between a girl "making it" or "falling through the cracks." What do within-girl cultural differences look like? This workshop will help staff develop specific strategies and skills for providing culturally competent services to young women of color and their families/caregivers. What does it mean to be gender-responsive and culturally competent? What are the barriers to providing culturally competent services? What are the opportunities? What does it look like in day-to-day practice in juvenile justice programs? What resources are available?

Barbara Cheives is the President and CEO of Converge & Associates Consulting which specializes in race and ethnic relations consulting and Cultural Competency Training. Her consulting expertise includes law enforcement and public safety; media; education; and corporations. Barbara serves on numerous boards including the National Board of the Institute of Community Peace in Washington, DC and is President of National Coalition of 100 Black Women, Inc. Beach County, from the Class of 2002. Barbara has received numerous awards.

VOICES: Addressing Trauma with a Gender Responsive Approach

The VOICES curriculum was created by Dr. Stephanie Covington, Co-Director of the Center for Gender and Justice. VOICES was created to address the unique needs of adolescent girls and young women. It encourages them to seek and celebrate their "true selves" by providing a safe space, encouragement, structure, and the support they need to embrace their journeys of self-discovery. This session will focus on the development and implementation of trauma informed services and a variety of therapeutic approaches to address the lived experiences of trauma.

Kim Selvaggi currently consults for local and national organizations, including The Center for Gender and Justice, The Girls Circle Association, and the CT Department of Mental Health and Addiction Services. In recent years, she has provided training and technical assistance for the National Institute of Corrections, the Office of Juvenile Justice and Delinquency Prevention, The Girls Study Group, and the McArthur Foundation. Mrs. Selvaggi spent twelve years at the State of Connecticut Judicial Branch, Court Support Services Division in the Center for Best Practices. During her career there, she worked within juvenile probation, juvenile detention and the network of alternative sanctions programs for adults and juveniles, where she helped reform the justice system to become more gender responsive and trauma-informed.

RESPECTING DIVERSITY: Meeting the Needs of Lesbian, Bisexual, and Transgendered Youth

Emerging research indicates that approximately 13 percent of youth in detention facilities across the country are LGBT. Far too often, the juvenile justice system is characterized by a profound lack of acceptance of LGBT identity, based in large part on misconceptions about sexual orientation and gender identity. Scientific research finds that sexual orientation and gender identity are deep-seated, inherent aspects of personal identity. Some professionals mistake expressions of choice of hairstyle, clothing, mannerisms, and name as rebellious behavior to be corrected rather than what it is: an appropriate reflection of core identity. The workshop will provide accurate information and resources for increasing understanding on the lived experiences of lesbian, bisexual, and transgendered youth. Specific policies and practices will be provided as guidance for ensuring all youth are provided appropriate, fair and equitable services.

Cindy Watson serves as the Executive Director of JASMYN's whose mission is to support and empower lesbian, gay, bisexual, transgender (LGBT) and questioning youth by creating safe space, providing youth development services and bringing people and resources together to promote diversity and human rights. JASMYN is known around the country as an innovative LGBT youth center with a comprehensive array of youth programs and as an advocate for youth in foster care and educational settings. Cindy has an extensive career of advocacy and direct services to individuals who are victimized and marginalized. She worked at the Jacksonville Area Legal Aid where she administered a school-based project for victims of violence. She also served as an executive director of a rural women's center in Vermont and helped to start a battered women's shelter in Alaska.

STAFF MATTERS: Finding Professional Passion and Personal Balance in Your Work with Girls and Young Women

Dr. Lawanda Ravoira is a national expert, author, researcher and trainer on issues specific to justice-involved girls and young women. She is the founding Director of the National Council on Crime and Delinquency's (NCCD) Center for Girls and Young Women in Jacksonville, Florida. The NCCD Center for Girls and Young Women is a division of NCCD which is headquartered in Oakland, California, the oldest research and policy organization in the country. Under her leadership, the center provides advocacy, assessments, training, technical assistance, research and evaluations for states, local jurisdictions and individual agencies throughout the United States and internationally. Passion is a powerful and compelling emotion that has the potential to fill our personal and professional lives. This is a roll-up-your sleeves and take-off-your shoes workshop with experiential activities that provide tools and techniques you can practice to create, celebrate and sustain your passion for working with girls and young women.

FJJA/DJJ to Host Civil Citation Roundtable Discussions at 2012 Adolescent Conference

At the 2012 Adolescent Conference in Orlando, FJJA and DJJ will be hosting discussions on DJJ's efforts to enhance civil citation efforts. In 2011, legislation gave DJJ the responsibility of developing new guidelines on implementation of civil citation programs to 1st time misdemeanants as well as requiring data entry into the JJIS system.

This roundtable discussion will take a look at current status of that effort, lessons learned and recommendations to improve going forward.

DJJ Prepares to Launch Review of Juvenile Justice Statutes

With legislative session over, Secretary Wansley Walters will be soon announcing the formation of a cross section of stakeholders to review the current Juvenile Justice Statutes. (Chapter 985 and 984) The review team will be chaired by Florida Supreme Court Justice Barbara Pariente, chair of the Supreme Court's Steering Committee on Families and Children, and Alan F. Abramowitz, Executive Director of the Guardian ad Litem Program.

Once started, the review process will take place throughout the summer, with final recommendations and proposed changes ready for next legislative session. Secretary Walters testified to the Legislature that she will be forming an oversight group, with three specific sub-groups, which will be taking input and working specifically on any proposed changes to the current statutes. The three subgroups will look at prevention and diversion, courts and process, and re-entry and aftercare.

To assist the Department of Juvenile Justice in this very important endeavor, FJJA has formed a small committee to develop how providers can participate in this process. We will be sharing more information at the FJJA Board meeting in April.

Colorado Juvenile Defender Coalition: Redirecting Justice: *The Consequences of Prosecuting Youth as Adults*

This report maintains that the direct-file law has been used to try thousands of Colorado youth as adults, inappropriately incarcerate them in adult jails and prisons, and mark them with lifelong felony convictions. This research shows that prosecuting children as adults is counterproductive to community safety because youth are less likely to be rehabilitated and become productive members of society.

Other findings:

Contrary to the perception that direct file is only used on the most serious cases; prosecutors are more often direct filing mid-level felony cases. The research showed that only 15% of direct file cases were homicides, and only 5% of cases were charged as first degree murder (only 8 of 84 first-degree murder charges resulted in a first-degree murder conviction).

Additionally, the vast majority of direct filed youth never have their case reviewed by a judge or jury. 95% of cases are plea-bargained. Only 28% of direct file cases are convicted of the highest offense charged, and 22% of cases are dismissed.

Direct file disproportionately affects children of color. 82% of admissions to Colorado's youthful offender system in 2009-2010 were black and Hispanic youth. In contrast, 75% of dismissed cases were white youth.

Mid-Year State Medicaid Budget Update for FY 2012 and a Look Forward to FY 2013

As states prepared their budgets for FY 2012, almost all continued to experience the ongoing effects of high unemployment and depressed state revenue collections. Most states were forced to dramatically increase FY 2012 state spending for Medicaid by an average of 28.7% largely to replace temporary Medicaid federal stimulus funds that expired in June 2011. The outlook for 2013 and beyond remains difficult with continued pressure to find Medicaid cuts, although few options for additional savings remain. To read report, [click here](#).

The Sentencing Project: *The Lives of Juvenile Lifers*

While the Supreme Court reviews this issue, a new report investigates the life experiences of individuals serving sentences of life without parole for offenses committed as juveniles and presents findings from the first-ever national survey of this population. It provides a comprehensive look that offers new perspectives on people who committed crimes before the age of 18. Almost 1,600 individuals responded to questions about their circumstances prior to conviction and their experiences in prison. Among the report's findings:

- One in three of the respondents were living in public housing prior to incarceration.
- 79 % reported witnessing violence in their homes.
- Almost 50% surveyed experienced physical abuse, almost 80 % of girls.
- One in five reported histories of sexual abuse, and 77.3% of female prisoners reported abuse as girls. To read report, [click here](#).

Realizing that institutionalization or incarceration was the juvenile justice system's response to addressing the needs of girls who committed delinquent acts and/or status offenses, Ms. Burke founded PACE Center for Girls in 1985. Following the success of that single program, Ms. Burke led a statewide expansion. Today, PACE has 17 centers throughout Florida, and has helped over 29,000 young women

Two Special Training Events To Be Held During The 2012 Adolescent Conference

In collaboration with the Florida Department of Juvenile Justice, the Florida Juvenile Justice Association is pleased to announce two special training events that will take place during the 2012 Adolescent Conference in Orlando.

Basic Motivational Interviewing and Stages of Change

This 2-day training event will take place from 9 am to 5 pm Monday and Tuesday, April 23-24. Upon completion participants will be certified in Motivational Interviewing. *Space is limited to 30 participants and is on a first come, first served basis.* Motivational Interviewing is a directive, client-centered cognitive-behavioral intervention for eliciting behavior change by helping youth to explore and resolve ambivalence. Participants will learn:

- about cognitive restructuring
- skill development
- effective communication with youth
- how to encourage youth to examine their cognitions
- how to challenge a youth's beliefs
- how to alter a youth's behaviors.

The DJJ curriculum was developed in accordance with the requirements recommended by William R. Miller, Ph.D., and Stephen Rollnick, Ph.D. and includes the use of interactive exercises to increase audience interest and encourage participation.

Protective Action Response (PAR) Refresher

The Protective Action Response (PAR) Refresher program will take place from 8 am to 5 pm Monday, April 23 and meets the requirements for the annual in-service PAR training pursuant to 63H-1.012. Space is limited and is on a first come, first served basis.

Participants will be trained to effectively maintain safety and order setting by preventing conflicts through the use of appropriate responses to the youth's behaviors and minimizing conflicts through the use of verbal de-escalation and the minimum amount of force necessary. In addition, the training helps participants to develop the personal confidence to apply DJJ-approved techniques correctly and in the most appropriate situation.
