Adolescent Conference A Success

The 2012 Adolescent Conference was a success, with over 500 professionals attending the event. This year's theme, "Unsung Heroes" underscored the work of dedicated staff throughout the state who work with Florida's at-risk youth every day.



Keynote speakers included Wansley Walters, Secretary for the Florida Department of Juvenile Justice, Shay Bilchik, Director of the Georgetown University Center for Juvenile Justice Reform, and Jaiya John, the founder of Soul Water Rising, a global human mission based in Silver Spring, Maryland. Secretary Walters shared the successes and challenges of the current efforts of the Florida DJJ to develop a more robust front end system through enhanced civil citation, prevention, and diversion services with more focused services based on assessed needs. Shay Bilchik spoke of the partnership between the Georgetown Center and the Florida DJJ on the Juvenile Justice System Improvement Project (JJSIP), which will eventually provide a framework for implementing best practices throughout the entire juvenile justice system.



Jaiya John delivered an inspirational message on the importance of working with at-risk youth. A foster youth, Jaiya shared his life story and spoke about the conflict and trauma of vulnerable young lives, including the fragile journey from childhood through adulthood. Jaiya encouraged individuals who work with at-risk youth to look within themselves to ensure that they are taking care of their own physical, emotional and spiritual health.

Recently Released Reports

New Reports Reveal Discriminatory Juvenile Justice Practices in Tennessee and Nebraska

In a recently released report, the U.S. Department of Justice documented that young black children in the juvenile justice system in Memphis, Tennessee, were more likely than white children to be detained and even tried as adults -- for the same crimes. After a review of over 60,000 Memphis juvenile court cases, the report found "serious and systematic" failures not only based on race, but on a failure to protect the due process rights of youth. The report does not recommend any official action against the juvenile court and juvenile court officials have begun moving to remedy discriminatory practices.

New Legislation in Colorado Attempts to Stop Direct File of Youth

Youth in trouble with the law in Colorado now have the right to judicial review before being transferred to the adult criminal justice system. On April 20, Governor Hickenlooper signed HB1271 into law, thanks in large part to the work of NJJN's Colorado members. The Colorado Juvenile Defender Coalition led the effort in partnership with the Colorado Criminal Defense Bar and the support of the Pendulum Foundation. Under HB 1271, prosecutors no longer have unilateral discretion to transfer youth to the adult criminal justice system. The new law:

- Raises the minimum age of direct file to 16;
- Limits the offenses to the most serious crimes (class 1, 2, violent sex offenses) and to repeat offenses (mid-level violent crimes and other sex offenses with prior felony adjudication);
- Provides for reverse transfer hearings (to occur at the time of preliminary hearing);
- Reforms youth sentencing (no mandatory minimums for mid-level crimes of violence, optional juvenile treatment for certain offenses, and misdemeanor convictions have to be dealt with in juvenile court).


Home Builders Institute C-CORE Orlando Members Lend a Hand to Rebuilding Together

Mentors and youth from the Orlando Home Builders Institute (HBI) C-CORE Mentoring Program recently participated in "National Rebuilding Day," the signature event of *Rebuilding Together*. National Rebuilding Day is a special day that brings national attention to the plight of America's low-income homeowners and the communities in which they live. Nearly 40 HBI C-CORE mentors and youth, along with local HBI Project CRAFT participants, were thrilled to take part in this worthwhile community service project on the home of a disabled Colony Cove resident. It took the group approximately five hours to complete painting and landscaping projects on the home that was in great need of these improvements.



When one youth was recently asked about their C-CORE experience, she said, "C-CORE has become my family. My participation has improved my relationship with my family!" Another youth stated that they "used to do activities with no meaning. Now, I understand what is important in life and that includes giving back". "Volunteer opportunities like this help make a huge difference to the local community and we are thrilled to put our skills to the test and lend a helping hand."

Dade Juvenile Residential Facility Youth Visit and Speak at Area Schools


