Supreme Court Rejects Juvenile Life Without Parole

In a 5-4 decision, the Supreme Court ruled on June 25th, that the Eighth Amendment forbids sentencing that mandates life in prison without possibility of parole for juvenile murderers. There are approximately 80 fourteen-year-olds nationwide who are serving such sentences.

In 2005 –in a case called *Roper v. Simmons*–the court rejected the death penalty for juveniles, and in 2010—in *Graham v. Florida*, it said that juveniles who commit non-homicide offenses can no longer receive sentences of life without parole. Those decisions were written by Justice Anthony Kennedy who relied on scientific evidence regarding the development of children's brains.

The recent decision stems from two cases—*Jackson v Hobbs* and *Miller v Alabama*—involving 14-year-olds convicted of murder and sentenced to mandatory life terms.

Justice Elena Kagan wrote the majority opinion, holding that life without possibility of parole for juveniles violates the Eighth Amendment's prohibition of cruel and unusual punishment, citing as precedent *Roper v Simmons*. "That right flows from the basic "precept of justice that punishment for crime should be graduated and proportioned," to both the offender and the offense," Kagan wrote. Chief Justice John Roberts wrote the dissenting opinion.

The Eckerd Family Foundation Helps Fund Florida DJJ Civil Citation Efforts

Secretary Walters recently shared that the Eckerd Family Foundation has granted DJJ funding to support counties as they begin to implement new civil citation programs or to improve existing programs. The grant allows stakeholders to tour other model civil citation sites, such as the program in Brevard County.

In 2009, the Eckerd Family Foundation was instrumental in assisting FJJA member Crosswinds Youth Services with developing a civil citation program in Brevard County through the funding of a planning grant. In addition to Crosswinds Youth Services, partners of this effort include the Brevard County sheriff's office, local police chiefs, the chief judge and representatives of the state attorney's office, public defender's office, Department of Juvenile Justice and Brevard County Public Schools. This successful model was highlighted this year in a FJJA newsletter and recently at the 2012 Adolescent conference, (along with Miami Dade Juvenile Services and DISC Village) where a Civil Citation meeting showcased three locally designed civil citation programs throughout the state.

Department of Justice Releases Tennessee Report

The US Department of Justice has released a report following a comprehensive investigation of the Juvenile Court of Memphis and Shelby County (JCMSC), and the Shelby County Juvenile Detention Center in Tennessee. The investigation, found a pattern or practice of unconstitutional conduct in several areas:

- Failure to provide timely and adequate notice of charges to children appearing on delinquency proceedings;
- Failure to protect youth from self-incrimination during probation conferences;
- Failure to hold timely probable cause hearings for youth arrested without a warrant;
- Failure to provide adequate due process protections for children before transferring them to the adult criminal court;
- The disparate treatment of African-American children; and
- Failure to adequately protect detained youth from self-harm and unnecessary and excessive restraints.

Justice Policy Institute Report

The report, *Mindful of the Consequences*, looks at how to improve public safety in Washington D.C. through a comprehensive approach that involves multiple strategies to improve outcomes for youth before they get caught up in the justice system, a victim of crime, or both. The report states that too many D.C. youth go undiagnosed and undertreated for mental illnesses and trauma that often contribute to delinquency, poor school performance and later encounters with the justice system.
