OJJDP & NCCD Launch National Girls Institute Website

Founded in 2010, The National Girls Institute (NGI) is a federally-funded partnership between the National Council on Crime and Delinquency (NCCD) and the Office of Juvenile Justice and Delinquency Prevention (OJJDP). NGI is a research-based training and resource clearinghouse designed to advance understanding of girls' issues and improve program and system responses to girls in the juvenile justice system. NGI activities include conducting a national assessment of training and technical assistance needs; developing standards of care; providing access to relevant resources; and providing gender-responsive training and technical assistance. NGI provides direction for advancing the application of research and information to practice to improve national, state, and local responses to girls, and assists agencies to improve capacity by providing training and technical assistance along the entire continuum of services to better meet the needs of girls and staff who work with them. U.S. Department of Justice: *Fact Sheet on Bullying*

Bullying includes repeated harmful acts and a real or perceived imbalance of power. Bullying creates a climate of fear in schools, on playgrounds, in neighborhoods, in juvenile detention facilities, and in gangs. Some 13.2% of survey participants reported having been physically bullied during the previous year. In the United States, 13% of 6th- through 10th-grade students bully and 6% are both victims and bullies. In a survey of American middle and high school students, 66% of bullying victims believed school professionals responded poorly to bullying problems. Bullying takes place more often at school than on the way to and from school. Male bullying declines after age 15 and female bullying after age 14. U.S. Department of Justice: *Fact Sheet on Mentoring*

Mentoring is based on the premise that predictable, consistent relationships with stable, competent adults can help youth cope with challenges and steer clear of high-risk behaviors. Of the 17.6 million young people who could benefit from having a mentor, only 2.5 million were in formal, one-to-one mentoring relationships in 2005. Most mentoring relationships last an average of 9 months, but 38% of mentors spent at least 12 months with their mentees. Only 16% of mentors had mentees in the juvenile justice system, but 67% of mentors expressed a willingness to work with this population. According to a study of the Big Brothers Big Sisters of America program, little brothers and little sisters were 46% less likely than their peers without mentors to initiate drug use during the study period.

Dept of Justice: *You're an Adult Now: Youth in Adult Criminal Justice Systems*

Juveniles transferred to adult corrections systems reoffend at a higher rate than those who stay in the juvenile justice system, according to a new report from the National Institute of Corrections (NIC). The report also found insufficient evidence that trying youths as adults acts as a crime deterrent.

Youth transferred to the adult corrections system recidivate at a higher rate than those kept in the juvenile justice system. Pretrial, post-conviction, and community supervision corrections systems face challenges keeping youth safe, effectively providing for their services and supervision, and containing costs required to serve youth appropriately. Due to these and other challenges corrections systems face when managing these youth, the transfer of juveniles in adult institutions might run counter to correctional and rehabilitative goals. To overcome these challenges, a number of states and localities have developed innovative ways of managing youth when they have been charged, convicted, and committed to the adult corrections system. These changes are helping improve public safety, contain costs, successfully rehabilitate youth, and help them transition to adulthood. [Click here for report.](#)

National Association of State Directors of Special Education: *Reentry Programs for Students with Disabilities in the Juvenile Justice System: Four State Approaches*

Evidence strongly supports the idea that juvenile offenders, both with and without disabilities, are significantly more likely to experience successful reentry into their home schools and communities if appropriate programs and supports are in place. This document defines reentry, describes recent federal efforts to support successful reentry for youth, discusses the prevalence of youth with disabilities in the juvenile justice system, explains why reentry programming matters, and summarizes recommended strategies for successful reentry. It also describes four states' efforts (Arizona, Georgia, Hawaii, and Oregon) to support the successful reentry of juvenile offenders into their home schools and communities. FJJA 2012 Legislative Agenda

No Funding Cuts to Juvenile Justice.

Over the last 3 years, DJJ reductions have amounted to close to \$167 million dollars. Last year, the agency took a cut of more than \$70 million dollars. As DJJ works to improve the system of care, maintaining current levels of funding will ensure further success in the reduction of crime and other related costs, and second, prevent the flow of youth into adult corrections, reducing the need for future prison construction by taxpayer dollars.

FJJA Recommends:

Taking into consideration the significant budget cut to DJJ last year, FJJA recommends that DJJ be spared further reductions in upcoming session.

Increase Investment in Community Based Services.

Investments should focus on the following program areas: 1) prevention, early intervention and diversion; 2) specialized residential; 3) transition, reentry and aftercare; and 4) education, career education and industry certification.

FJJA Recommends:

If the revenue picture improves – investing additional dollars in community based services and contracted rates will further enhance youth success, lower recidivism rates, provide maximum return on taxpayer investment and sustain proven programs.

PACE Founder To Be Recognized By Governor Rick Scott

Florida Governor Rick Scott has selected three outstanding Florida women for induction into the Florida Women's Hall of Fame; Dr. Ruth H. Alexander, Elizabeth "Budd" Bell, and Vicki Bryant Burke. Governor Scott chose the three women from a list of 10 distinguished nominees selected by the Florida Commission on the Status of Women for making significant contributions to the improvement of life for women and all citizens of Florida.

Governor Scott will conduct the ceremony for the Hall of Fame on Tuesday, March 6, 2012 at 5:00 p.m. in the Capitol Courtyard in Tallahassee. The founder of PACE Center for Girls, Vicki Bryant Burke, is one of the recipients.

Realizing that institutionalization or incarceration was often the juvenile justice system's response to addressing the needs of girls who committed delinquent acts and/or status offenses, Ms. Burke founded PACE Center for Girls; the first and only non-residential program for troubled adolescent females in Florida in 1985. Following the success of that single program, juvenile judges began requesting that PACE expand to their cities, and Ms. Burke led a statewide expansion to include PACE Centers in Bradenton, Orlando, Miami, Fort Lauderdale, Pensacola, and Tallahassee.

Today, PACE has 17 centers throughout Florida, and has helped over 29,000 young women. Ms. Burke is still working with females; she is currently working with female ex-offenders helping them transition back into their community, find meaningful work, and lead productive lives.

"These three women exemplify what makes Florida the best place in the country to live-the quality of our people. With selfless dedication and love they have lifted countless individuals and families, and by so doing they have lifted our state as a whole," state Governor Scott. FJJA/DJJ to Host Roundtable Discussions at 2012 Adolescent Conference

At the 2012 Adolescent Conference in Orlando, FJJA and DJJ will be hosting roundtable discussions relating to the Georgetown University Juvenile Justice System Improvement Project (JJSIP) as well as DJJ's current activities to enhance Civil Citation efforts.

Georgetown University Center for Juvenile Justice Reform recently selected Pinellas County, Florida to participate in an 18-month project, which is designed to help states improve outcomes for juvenile offenders by better translating knowledge on "what works" into everyday practice and policy. DJJ has plans to expand efforts beyond the initial pilot in Pinellas County and looks to inform thought leaders around the state on the status of this project.

In 2011, new legislation gave DJJ the responsibility of developing new guidelines on implementation of civil citation programs to 1st time misdemeanants as well as requiring data entry into the JJIS system. This roundtable discussion will take a look at current status of that effort, lessons learned and recommendations to improve going forward.

FJJA Members Participate in Art Auction to Celebrate DJJ Youth Success

FJJA Members DISC Village and Twin Oaks Juvenile Development recently partnered with the Florida Juvenile Justice Foundation to host an art auction celebrating the artistic talent of juvenile justice involved youth. The art exhibited was created by youth from the Volusia Regional Detention Center (VRDC) and Prodigy Cultural Arts Program. Prodigy, a research-based prevention, intervention and diversion program for at-risk youth ages 7 to 17, uses visual and performing arts as way to teach youth who live in high risk areas or who have been diverted or adjudicated from the juvenile justice system. Twin Oaks Dove Vocational Academy provided the catering for the reception, the Pensacola Boys Base framed various pieces of the art and PACE Center for Girls welcomed attendees to the reception.

DJJ to Announce Team to Review Juvenile Justice Statutes

In the next month, Secretary Wansley Walters will announce the formation of a cross section of stakeholders to review the current Juvenile Justice Statutes (Chapter 985 and 984) . The review team will be chaired by Florida Supreme Court Justice Barbara Pariente, chair of the Supreme Court's Steering Committee on Families and Children, and Alan F. Abramowitz, Executive Director of the Guardian ad Litem Program. The review process will take place following the close of this legislative session, and will commence throughout the summer, with final recommendations ready for next legislative session. To assist the Department of Juvenile Justice in this very important endeavor, FJJA has formed a small committee to participate in this process. We will be reaching out to members for input soon.

NCCD Selected by OJJDP to Assist Task Force on Children Exposed to Violence

Launched in 2011, the National Task Force on Children Exposed is taking input from experts in the field, victims and families, service providers, and the public. The task force will identify promising practices, programming, and community strategies used to prevent and respond to children's exposure to violence. The recommendations from the taskforce will shape policy and legislation around children's exposure to violence.

The National Center for Crime and Delinquency (NCCD) is assisting the task force to convene four public hearings to learn from practitioners, policymakers, advocates, academics, and communities about the extent and nature of the problem of children's exposure to violence in the U.S. The first hearing (Baltimore) and second hearing (Albuquerque) have already been held. The third and fourth hearings will take place March 20 in Miami and April 24 in Detroit. The task force will issue a final report of findings and policy recommendations, which will serve as a blueprint for preventing children's exposure to violence and for mitigating the negative effects experienced by children exposed to violence across the U.S. The Miami hearing will be held on March 19-21, 2012, at the University of Miami, Newman Alumni Center, hosted by the University of Miami School of Law.

Prodigy Teens Attend Children's Week Events at the Capital

Prodigy Youth from Hillsborough, Pinellas, Sarasota, Orange and Pasco counties recently returned from a life-changing trip to the state Capitol speaking with lawmakers. For some of these teens, this trip was the first time they traveled outside of Tampa. For others, it was their first stay in a hotel. And, most importantly, it was the first time they had an opportunity to shake hands with state lawmakers who hold the decision making power over funding Prodigy, the very program that has transformed their life.

The trip was a part of the annual "Children's Week" when a coalition of organizations from across Florida who unite together to advocate for children and family issues to the state legislature.

In addition to meeting directly with legislators, and a picture with the Governor, the youth participated in a packed agenda that included an Old Capitol tour, a visit to the Challenger Learning Center to experience a space flight simulator and IMAX film, and a tour of Florida State University. Prodigy youth who participated in this Tallahassee trip ranged from 13 to 17 years old, and live in Hillsborough, Pinellas, Sarasota, Orange and Pasco counties. Home Builders Institute Project Craft

(HBI) Project CRAFT-Okeechobee Youth Development Center (OYDC) already is working hard in 2012 to exceed the success of its 2011 community outreach. The students are building toys and furniture for local non-profits. They also are assisting the Kiwanis Club with its Adam Bryant Regatta fundraiser, which raises money to send a local student to EMT and firefighter school, and its efforts to help local disabled children and young adults fulfill their dreams. HBI Project CRAFT-OYDC is reaching out to different vendors, businesses and individuals to support these efforts.

The students continue to maintain the HVAC systems at the center throughout the winter months and take advantage of the time normally spent doing lawn maintenance to work on finishing the computer lab. This month they built a raised floor, installed new vinyl composite tile and window treatments in the lab. As they complete the finishing touches, the computer lab is now presentable, functional and fully occupational. The lab allows students to research jobs and educational opportunities prior to going home, so they can increase their success. One former student, who still lives on campus, currently is enrolled in online classes at the local Indian River State College (IRSC). Another student was able to pre-enroll in college prior to leaving and will start classes when he returns home.

The young men enjoyed a presentation presented by Mr. Bruce Chesser from the South Florida Water Management District (SFWMD). Mr. Chesser explained the array of employment opportunities they could be eligible for at SFWMD. Many of the positions are directly related to what the students are learning in HBI facility maintenance training. He emphasized that regardless of their histories, they can still find a successful career.

Ensuring a Good Night's Sleep

HBI Project Craft Orlando recently partnered with *Rebuilding Together Orlando*, a national nonprofit working to preserve affordable homeownership and revitalize communities, the Mustard Seed and the Furniture Bank in Central Florida, to launch "a Door to a Good Night's Sleep" bed project.

This project, using a variety of recycled material such as wooden doors and discarded bed frames, created a solution to provide a good night's sleep for children in need.

HBI Orlando Instructors Frank Franco and Brian Andrews worked with HBI students to manufacture beds, which would be given to deserving families. HBI was able to manufacture 50 bunk beds.

The beds were taken to the JW Marriot Grande Hotel in Orlando Florida to be assembled as a Team Building challenge for Hospira Pharmaceutical Company's "Helping Hands of Hospira 2012 Outreach Program". Hospira used this project as their community service event. HBI students and staff worked alongside 850 Hospira workers and volunteers to assemble and paint the beds. To accommodate all 850 volunteers the event was staged in the parking lot of the hotel. As the sun cast down and a cool breeze blew, the DJ played heart pumping music as HBI students worked alongside Hospira teams to assemble beds.

HBI's Vice President Dennis Torbett, Senior Director of Operations John Hattery, and Director for Special Projects Tadar Muhammad were on hand for the event. This was truly a most memorable event for all involved but most importantly for the children that will benefit from the project by getting a "Good Night's Sleep"!
